<u>REGISTRATION</u>: There is a \$100.00 <u>NON-REFUNDABLE/NON-TRANSFERABLE</u> registration fee per child due at registration.

<u>MATERIAL FEE:</u> A <u>NON-REFUNDABLE/NON-TRANSFERABLE</u> material fee is **due at registration** and will be used to purchase educational/consumable supplies and to *help* cover the cost of field trips (in PreK & K classes only).

<u>SAFETY & SECURITY FEE</u>: A \$150 <u>NON-REFUNDABLE/NON-TRANSFERABLE</u> safety & security fee is **due at registration** and will be used to pay for an off-duty City of Winter Park Police officer to monitor and protect the school & FUMCWP campus between the hours of 8:15 AM – 2:15 PM on school days.

#### **TUITION**

Tuition is based on a ten-month calendar, beginning in August & ending in May. TUITION IS AN ANNUAL FEE which can be divided into 10 equal installments, for your convenience. Tuition is payable on an annual, semi-annual, or monthly basis. Full year tuition installments are due August 1st, semi-annual installments are due August 1st, and monthly installments are due the first day of each month. MSEE offers TUITION EXPRESS, an automated payment processing system that allows you to pay thru automated deductions of your debit card or checking account. There is a \$20.00 late fee charged for tuition installments received after the 10th of each month. A WRITTEN two-week notice to the school office is required when withdrawing your child from the program for any reason. You will be responsible for payment during this two-week period, whether your child is in the classroom. FIRST MONTH'S INSTALLMENT IS DUE AT REGISTRATION and is NON-REFUNDABLE/NON-TRANSFERABLE.

#### **CHILDREN & DISCIPLINE**

At MSEE, we are committed to the belief that children learn best in an atmosphere which values and respects the uniqueness of each individual child. Our discipline policy reflects our school-wide philosophy of positive guidance with children. The word discipline means to "disciple or teach." Our goal is to teach or guide children until they can self-regulate.

Our program utilizes the positive techniques of guidance, including redirection, anticipation, and elimination of potential problems, positive reinforcement, and encouragement. Through language, role modeling, and praise, children will be encouraged to cooperate. We begin this process with the youngest children by creating and setting up an environment that allows for sufficient space and duplication of materials. Consistent, reasonable rules and daily routines are established, and we stress the importance that they be followed by everyone. We have logical consequences for breaking those rules and will give children more personal responsibility as they are able to assume it. As children gain social skills and understanding, they will be given choices and age-appropriate rules with logical consequences followed by learning appropriate negotiation and problem-solving skills. As the circumstances may require, we will use supervised time apart from the group.

In the event of persistent problems with a child, we will work closely with you, so that together with a mutual understanding, we can direct a positive behavioral pattern. If a child has persistent difficulty controlling behavior to the extent that there is continual disruption to the class, making it impossible for other children to have a successful school experience, a conference will be necessary to determine the continuation of the child in our school program.

In all events, we ask parents to work together with us to achieve these goals. At MSEE, let us know the joyous happenings, the upsetting experiences, or important changes at home that may affect behavior. It is also important to let teachers know what a child has been told about an impeding birth, serious illness, being adopted, or a recent death, so any conversation can be followed with complete empathy.



# FACTS ABOUT HEATSTROKE:

It only takes a car 10 minutes to heat up 20 degrees and become deadly.

Even with a **window cracked**, the temperature inside a vehicle can cause heatstroke.

The body temperature of a child increases **3 to 5 times faster** than an adult's body.

# A PREVENTION TIPS:

- Never leave your child alone in a car and call 911 if you see any child locked in a car!
- Make a habit of checking the front and back seat of the car before you walk away.
- Be especially mindful during hectic or busy times, schedule or route changes, and periods of emotional stress or chaos.
- Create reminders by putting something in the back seat that you will need at work, school or home such as a briefcase, purse, cell phone or your left shoe.
- Keep a stuffed animal in the baby's car seat and place it on the front seat as a reminder when the baby is in the back seat.
- Set a calendar reminder on your electronic device to make sure you dropped your child off at child care.
- Make it a routine to always notify your child's child care provider in advance if your child is going to be late or absent; ask them to contact you if your child hasn't arrived as scheduled.

# **During the 2018 legislative session,**

a new law was passed that requires child care facilities, family day care homes and large family child care homes to provide parents, during the months of April and September each year, with information regarding the potential for distracted adults to fail to drop off a child at the facility/home and instead leave them in the adult's vehicle upon arrival at the adult's destination.

# What should I do if my child gets sick?

Consult your doctor and make sure your child gets plenty of rest and drinks a lot of fluids. Never give aspirin or medicine that has aspirin in it to children or teenagers who may have the flu.

# CALL OR TAKE YOUR CHILD TO A DOCTOR RIGHT AWAY IF YOUR CHILD:

- · Has a high fever or fever that lasts a long time
- · Has trouble breathing or breathes fast
- · Has skin that looks blue
- · Is not drinking enough
- Seems confused, will not wake up, does not want to be held, or has seizures (uncontrolled shaking)
- · Gets better but then worse again
- Has other conditions (like heart or lung disease, diabetes) that get worse



# How can I protect my child from the flu?

A flu vaccine is the best way to protect against the flu. Because the flu virus changes year to year, annual vaccination against the flu is recommended. The CDC recommends that all children from the ages of 6 months up to their 19th birthday receive a flu vaccine every fall or winter (children receiving a vaccine for the first time require two doses). You also can protect your child by receiving a flu vaccine yourself.

# What can I do to prevent the spread of germs?

The main way that the flu spreads is in respiratory droplets from coughing and sneezing. This can happen when droplets from a cough or sneeze of an infected person are propelled through the air and infect someone nearby. Though much less frequent, the flu may also spread through indirect contact with contaminated hands and articles soiled with nose and throat secretions. To prevent the spread of germs:

 Wash hands often with soap and water.

- Cover mouth/nose during coughs and sneezes. If you don't have a tissue, cough or sneeze into your upper sleeve, not your hands.
- Limit contact with people who show signs of illness.
- Keep hands away from the face. Germs are often spread when a person touches something that is contaminated with germs and then touches his or her eyes, nose, or mouth.





# When should my child stay home from child care?

A person may be contagious and able to spread the virus from 1 day before showing symptoms to up to 5 days after getting sick. The time frame could be longer in children and in people who don't fight disease well (people with weakened immune systems). When sick, your child should stay at home to rest and to avoid giving the flu to other children and should not return to child care or other group setting until his or her temperature has been normal and has been sign and symptom free for a period of 24 hours.

## What is the influenza (flu) virus?

Influenza ("the flu") is caused by a virus which infects the nose, throat, and lungs. According to the US Center for Disease Control and Prevention (CDC), the flu is more dangerous than the common cold for children. Unlike the common cold, the flu can cause severe illness and life threatening complications in many people. Children under 5 who have the flu commonly need medical care. Severe flu complications are most common in children younger than 2 years old. Flu season can begin as early as October and last as late as May.



# How can I tell if my child has a cold, or the flu?


Most people with the flu feel tired and have fever, headache, dry cough, sore throat, runny or stuffy nose, and sore muscles. Some people, especially children, may also have stomach problems and diarrhea. Because the flu and colds have similar symptoms, it can be difficult to tell the difference between them based on symptoms alone. In general, the flu is worse than the common cold, and symptoms such as fever, body aches, extreme tiredness, and dry cough are more common and intense. People with colds are more likely to have a runny or stuffy nose. Colds generally do not result in serious health problems, such as pneumonia, bacterial infections, or hospitalizations.

# **General Requirements**

Every licensed child care facility must meet the minimum state child care licensing standards pursuant to s. 402.305, F.S., and ch. 65C-22, F.A.C., which include, but are not limited to, the following:

# **Health Related Requirements**

- ☐ Emergency procedures that include:
  - Posting Florida Abuse Hotline number along with other emergency numbers.
  - Staff trained in first aid and Infant/Child CPR on the premises at all times.
  - Fully stocked first aid kit.
  - A working fire extinguisher and documented monthly fire drills with children and staff.
- Medication and hazardous materials are inaccessible and out of children's reach.

#### **Training Requirements**

- ☐ 40-hour introductory child care training. □ 10-hour in-service training annually.
- □ 0.5 continuing education unit of approved training or 5 clock hours of training in early literacy and language development.
- □ Director Credential for all facility directors.

#### **Food and Nutrition**

☐ Post a meal and snack menu that provides daily nutritional needs of the children (if meals are provided).

## **Record Keeping**

- ☐ Maintain accurate records that include:
  - Children's health exam/immunization record.
  - Medication records.
  - Enrollment information.
  - Personnel records.
  - Daily attendance.
  - Accidents and incidents.
  - Parental permission for field trips and administration of medications.

# **Physical Environment**

- ☐ Maintain sufficient usable indoor floor space for playing, working, and napping.
- □ Provide space that is clean and free of litter and other hazards.
- ☐ Maintain sufficient lighting and inside temperatures.
- ☐ Equipt with age and developmentally appropriate toys.
- ☐ Provide appropriate bathroom facilities and other furnishings.
- □ Provide isolation area for children who become ill.
- ☐ Practice proper hand washing, toileting, and diapering activities.

# **Quality Child Care**

Quality child care offers healthy, social, and educational experiences under qualified supervision in a safe, nurturing, and stimulating environment. Children in these settings participate in daily, age-appropriate activities that help develop essential skills, build independence and instill self-respect. When evaluating the quality of a child care setting, the following indicators should be considered:

#### Quality Activities

- Are children initiated and teacher facilitated.
- ☐ Include social interchanges with all children.
- Are expressive including play, painting, drawing, story telling, music, dancing, and other varied activities.
- ☐ Include exercise and coordination development.
- Include free play and organized activities.
- ☐ Include opportunities for all children to read, be creative, explore, and problem-solve.

#### **Quality Caregivers**

- ☐ Are friendly and eager to care for children. Accept family cultural and ethnic differences.
- Are warm, understanding, encouraging, and responsive to each child's individual needs.
- ☐ Use a pleasant tone of voice and fregently hold, cuddle, and talk to the children.
- ☐ Help children manage their behavior in a positive. constructive, and non-threatening manner.
- ☐ Allow children to play alone or in small groups. Are attentive to and interact with the children.
- Provide stimulating, interesting, and educational activities.
- ☐ Demonstrate knowledge of social and emotional needs and developmental tasks for all children.
- □ Communicate with parents.

#### **Quality Environments**

- Are clean, safe, inviting, comfortable, child-friendly.
- Provide easy access to age-appropriate toys.
- Display children's activities and creations.
- ☐ Provide a safe and secure environment that fosters the growing independence of all children.
